
#### Founders Growth

# 9. <u>Political Activities</u> Policy

### RESPONSIVE EDUCATION SOLUTIONS POLITICAL ACTIVITIES POLICY

#### **PURPOSE**

As a 501(c)(3) organization, Responsive Education Solutions ("ResponsiveEd") and persons acting on its behalf, including its directors, officers, employees, and volunteers, are strictly prohibited from engaging in political activity in a manner that is attributable to ResponsiveEd. Section 501(c)(3) of the Internal Revenue Code (IRS) absolutely prohibits ResponsiveEd and other tax-exempt organizations from participating or intervening, directly or indirectly, in political activities on behalf of, or in opposition to, a candidate for public office. Generally, this means ResponsiveEd may not endorse or oppose a candidate, make, publish, or distribute statements on behalf of or in opposition to a candidate, establish political action committees, or provide or solicit financial or other support for candidates at ResponsiveEd functions or through ResponsiveEd publications.

Given the significant risk to ResponsiveEd's tax-exempt status and exposure to other penalties, it is critical all ResponsiveEd directors, officers, employees, and volunteers adhere to this Political Activities Policy. Though this policy shall serve as a guide for ResponsiveEd on how to avoid prohibited political activity, it is not feasible for this policy to cover every possible scenario. Therefore, ResponsiveEd encourages anyone acting under this policy to consult with ResponsiveEd's General Counsel with any questions regarding this policy and its interpretation.

#### PROHIBITED POLITICAL ACTIVITY

Political activity prohibited under Section 501(c)(3) consists of support for or opposition to a political candidate, party, referendum, or political action committee ("PAC"), and "substantial" lobbying. Examples of activities to avoid include:

- 1. Making or soliciting campaign contributions to or for candidates or political organizations.
- 2. Publishing or distributing partisan campaign literature, a written public position statement, or other written or oral statement advocating for or against a particular candidate. This includes statements made to news media or on ResponsiveEd's social media pages. This also includes posting comments that favor or oppose candidates or political parties on any ResponsiveEd social media, including blogs, Facebook pages, twitter accounts, etc. (including director, officer, and employees accounts that are associated with ResponsiveEd).
- 3. Endorsing or rating candidates.
- 4. Using ResponsiveEd's resources, including its employees, facilities, or equipment, to influence an election.
- 5. Wearing political buttons or other political paraphernalia during a ResponsiveEd event/activity or as a ResponsiveEd representative.
- 6. Forwarding or otherwise sharing or transmitting an email or other electronic communication from any candidate, political party, PAC or any partisan political group that came to your ResponsiveEd email account. Do not use a ResponsiveEd email address to subscribe to candidate or political material or to otherwise interact with others (including candidates, political parties, PACs, or any persons or organizations) regarding any political topics. If you

- inadvertently receive candidate or political emails at work, delete them and unsubscribe your ResponsiveEd email address from the email list.
- 7. Attending political events as a representative of ResponsiveEd hosted by a political candidate, party, campaign, political action committee, or other entity in support of a candidate or failing to explicitly state attendance is in an individual capacity if there is any doubt regarding ResponsiveEd affiliation.

#### **USE OF RESPONSIVEED FACILITIES AND RESOURCES**

ResponsiveEd facilities and resources shall be used in such a way to avoid even the appearance of support for one political candidate over another, one party over another, or in support of a referendum or political action committee.

Accordingly, it is imperative that ResponsiveEd refrain from using the following resources for prohibited political activities:

- 1. ResponsiveEd physical facilities, except as noted below under Candidate Appearances;
- 2. ResponsiveEd funds or its sales tax exemption to purchase goods and services;
- 3. ResponsiveEd's name or logo on material intended for a political purpose;
- 4. An individual's ResponsiveEd title or position other than for the purpose of identification;
- 5. Time as an employee, officer, director or volunteer of or to ResponsiveEd;
- 6. ResponsiveEd communication channels, such as phone, email, computer, or internet systems and social media;
- 7. ResponsiveEd's mailing system, including mailing lists and postage machines; and
- 8. ResponsiveEd office supplies and other equipment, such as fax machines, printers, and copy machines.

While the above list is intended to be indicative of the types of ResponsiveEd resources that cannot be used for political activities under this policy, it is not exhaustive and any questions regarding the application of this policy should be directed to the Chief Legal Officer or General Counsel.

These organizational prohibitions that apply to employment or other association with ResponsiveEd do not inhibit an employee or other ResponsiveEd representative from individual participation in election activities, provided the employee or representative does not use ResponsiveEd resources or represent that he or she is acting as an employee, officer, or representative of ResponsiveEd.

If an employee or other responsiveed representative is asked or intend to formally endorse a candidate, serve as a member of a campaign, hold a leadership position with a political candidate or other campaign, host a political event at A personal residence or serve as a "co-chair" or in another leadership or sponsoring capacity, THE EMPLOYEE OR REPRESENTATIVE MUST ensure that such activities are clearly undertaken in HIS OR HER personal capacity consistent with this policy, and that there is no express or implied statement or other communication that suggests that ResponsiveEd is participating in the activity (or that THE EMPLOYEE OR REPRESENTATIVE IS acting on ResponsiveEd's behalf or with ResponsiveEd's authorization in participating in the activity).

IF ANY COMMUNICATION IDENTIFIES AN EMPLOYEE OR REPRESENTATIVE'S POSITION WITH RESPONSIVEED, THE EMPLOYEE OR REPRESENTATIVE MUST ENSURE THAT SUCH COMMUNICATION INCLUDES A STATEMENT THAT REFERENCE TO THE RESPONSIVEED POSITION IS FOR IDENTIFICATION PURPOSES ONLY. THE RESPONSIVEED EMPLOYEE OR REPRESENTATIVE MAY NOT MAKE ANY POLITICAL STATEMENTS, PUBLICATIONS, COMMUNICATIONS, OR EXPENDITURES THAT CONVEY, EXPRESSLY OR IMPLIEDLY, THAT THEY ARE BEING MADE AT THE DIRECTION OR ON BEHALF OF, OR AUTHORIZED OR PAID FOR BY, RESPONSIVEED

#### CANDIDATE (INCLUDING INCUMBENT OFFICE-HOLDER) APPEARANCES

If a person who might be determined to be a "candidate" (including current elected officials) is proposed or contemplated to appear at a ResponsiveEd event, campus or other ResponsiveEd school-related activity or functions (including school tours)., written approval for such appearance must be requested and obtained from the Chief of Staff, Kalese Whitehurst, at <a href="kwhitehurst@responsiveed.com">kwhitehurst@responsiveed.com</a> after consultation with a supervisor, and the Superintendent or his or her designee, and consultation with the Chief Legal Officer or General Counsel.

Candidate appearances at any ResponsiveEd event must be conducted in a manner such that neither ResponsiveEd nor any of its directors, officers, or employees express any preference for, or opposition to, such candidate or any opposing candidate in any election.

By policy, ResponsiveEd will not allow any candidate to appear at any ResponsiveEd events that are held within thirty (30) days prior to any election (primary, special or general) in which such person is a candidate. .

The determination of whether a person is a "candidate for elective office" shall be made by the Chief Legal Officer or General Counsel of ResponsiveEd. A candidate running for public office, or his or her designee ("collectively referred to below as "candidate"), may appear at ResponsiveEd events for non-campaign related activities, in-person or virtually, if the following criteria are met:

- a. A candidate shall not be permitted to appear at any ResponsiveEd event held within 30 days prior to any election in which the candidate is seeking office;
- b. Permission to invite the candidate or accept a candidate's invitation must first be approved in writing by ResponsiveEd's Chief Legal Officer or General Counsel.;
- c. The candidate's appearance must be solely for reasons other than his or her candidacy;
- d. Any promotion of or invitation to the event shall not mention the candidacy and shall clearly communicate that ResponsiveEd does not endorse or oppose any candidate for public office;

- e. Prior to the event, ResponsiveEd shall provide the candidate with a copy of ResponsiveEd's Candidate and Incumbent Office-Holder Appearance Guidelines and Requirements (Exhibit A).
- f. Neither ResponsiveEd nor the candidate shall mention the campaign, his or her candidacy, or the impending election;
- g. Neither ResponsiveEd nor the candidate shall display or distribute materials that mention the candidacy, campaign, or election;
- h. The following disclaimer language should be included on event invitations, promotions or media recognition of the event (posts on social media, websites, etc.):

Responsive Education Solutions is a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. Responsive Education Solutions is prohibited by law from participating or intervening in any campaign of any candidate for public office. Nothing in this communication or any event or topic referenced in this communication is intended to be, or should be construed as, support of, or opposition to, any candidate for public office. References in this communication to any person or the title(s) or position(s) of any person are for identification purposes only. Responsive Education Solutions hereby disclaims any statement or other action, express or implied, supporting or opposing any candidate for public office.

- i. The climate of the event shall be nonpartisan, and no ResponsiveEd director, officer, employee, or volunteer shall express any preference for, or opposition to, the candidate, the candidate's party, or any other candidate or party;
- j. No campaigning or campaign fundraising may take place; and
- k. The event shall be organized by and remain under the control of ResponsiveEd at all times.

#### **AFFILIATION**s

ResponsiveEd should be mindful that its affiliation with other entities may expose ResponsiveEd to unauthorized political activity especially where the other entity is engaged in political activities. This mandates vigilance when collaborating with other entities and permitting those entities to link themselves with ResponsiveEd. Any event in which ResponsiveEd is involved with another entity and includes a candidate appearance must meet the requirements of this policy.

#### "Exhibit A"

#### CANDIDATE AND INCUMBENT OFFICE-HOLDER APPEARANCE GUIDELINES AND REQUIREMENTS

This letter is provided by Responsive Education Solutions ("<u>ResponsiveEd</u>") in connection with your appearance at an event held by or on behalf of RES. RES's appreciates your appearance at the event and your support of ResponsiveEd's work on behalf of students.

ResponsiveEd is a tax-exempt organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"). ResponsiveEd is prohibited under federal tax law from participating or intervening in any campaign on behalf of, or in opposition to, any candidate for public office (including publishing or distributing statements).

ResponsiveEd has identified that you are or may be a "candidate" for purposes of federal tax law applicable to ResponsiveEd. Accordingly, ResponsiveEd is providing you with this letter in order to ensure that your appearance at a ResponsiveEd event is consistent with restrictions imposed on RES under the Code and related provisions of laws of the State of Texas.

Please note that under ResponsiveEd policies and applicable federal tax law, a person who has not formally declared their candidacy for an elective office may still be considered a "candidate." ResponsiveEd's compliance policies require that RES ask that you assist it in complying with the following restrictions:

- 1. ResponsiveEd may introduce you for identification purposes only. ResponsiveEd will not reference in any introduction or make comments regarding your candidacy, incumbency or any opponent(s) that you may have in any election (formal, proposed, informal, or otherwise), or the fact of any election whether past, present, or future.
- 2. ResponsiveEd requests that during your appearance, you refrain from making reference to any election, to your candidacy or prospective candidacy, or to your incumbency. You may refer to an incumbent position for identification purposes only, such as "I am Jane Smith, Governor of the State of Texas."
- 4. ResponsiveEd requests that no fundraising or other advocacy effort occur during any appearance on any ResponsiveEd property or at any ResponsiveEd event. "Advocacy effort" means, in the broadest possible sense and includes, but is not limited to, soliciting support from attendees during informal conversations, making statements supporting any campaign (including your own) or supporting or opposing policy or other political positions advocated by any other candidate or political party, or any other partisan political organization (formal or informal).

ResponsiveEd looks forward to your support of ResponsiveEd's tax-exempt purposes and work on behalf of its students and appreciates your assistance in its compliance efforts. #### **EXHIBIT B**

#### **ACCOUNTING POLICY**

#### **PROHIBITION OF POLITICAL EXPENDITURES**

Responsive Education Solutions, as a 501(c)(3) organization for federal income tax purposes, is prohibited from engaging in political activities, including paying expenses in support of, or in opposition to, any candidate for any public office, partisan organization, political campaign, or any other person or entity acting in a partisan capacity. This policy is intended to ensure that ResponsiveEd does not pay or reimburse any expenses associated with such activities.

Upon receipt of a request for payment of any cost directly, in addition to taking other authorization steps applicable to the payment of any cost to be paid by ResponsiveEd (including through reimbursement), the person responsible for reviewing the cost should confirm that the cost is not associated with, or allocable to, supporting or opposing any candidate for public office, political party, campaign, or making of any political publications or statements. If the description of the cost suggests that there is **any** potential that the cost may be associated with any political activity, the person reviewing the cost should seek additional detail about the cost from the person requesting the payment or reimbursement. If it is unclear whether the cost is associated with political activity, then the person reviewing the cost must consult with the Chief Financial Officer regarding whether the cost should be paid and whether any remedial action should be taken.

The following language must be added to or otherwise included in any requisition or expense payment form (including reimbursement requests and credit card authorizations):

"The person(s) requesting the payment of the listed cost(s) affirms that no portion of the listed cost(s) were incurred for purposes of participating or intervening, directly or indirectly, in any political campaign on behalf of or in opposition to any candidate for any public office, and that such amounts were not incurred for any payment to or for the benefit of any candidate, political campaign, organization acting in a partisan capacity, or political party."
